

**The Regulations of the Conference
„Innovative Academy of Aesthetic Dermatology”
iADE 2026**

I. General Provisions

1. The terms used in these Regulations refer to the definitions specified in the General Regulations of the events organized by IADE Sp. z o. o. and also to the following definitions:
 - a) **Regulations** – these Conference Regulations which also govern the provision of electronic services;
 - b) **General Regulations** – these regulations which make up also the regulations for the provision of electronic services, applicable to all the Events organized by the Organizer, regardless of their type, venue, dates and form (onsite, online or hybrid), provided that the Regulations of these specific Events does not specify otherwise;
 - c) **Conference** – a training and scientific event, named “iADE 2026 – Innovative Academy of Aesthetic Dermatology”, organized by the Organizer;
 - d) **Organizer** - IADE Sp. z o.o. with the registered office in Warsaw, address: Kosiarzy str. No.: 9A, 02-953 Warszawa, incorporated in the District Court for the capital city of Warsaw, Department No.: 14 for Commercial Affairs of the National Court Register with the KRS number: 0001186906, NIP [tax identification number]: 1133175963; REGON [business classification number]: 54243599400000; email: kontakt@iade.pl; phone: +48 608 816 900;
 - e) **Website** – portal operated and administered by the Organizer at www.iade.pl devoted to the Conference, used, among other things, to register passive participants and to perform other activities related to the execution of the Contract.
2. The Regulations stipulate the rights and obligations of the Contracting Parties, Participants and Conference Organizer.
3. These Regulations will be available on the website and at the Conference registration desk.
4. The Contracting Parties and the Participants are obliged to read the Regulations and the General Regulations before the execution of the Contract and participation in the Conference.
5. These Regulations and the General Regulations are binding on all Contracting Parties and Conference Participants who are obliged to observe all the provisions thereof.
6. The Conference is intended for medical doctors and, in a limited scope, for Managers, i.e. individuals working in medicine, who are not laypersons as specified in the Act of April 7th, 2022, on medical devices. The event may include content or advertisements related to medical products intended for use by experts (i.e. professionals qualified in an appropriate field of healthcare or medicine).
7. The status of a physician is verified during registration, by means of providing the number of the Professional License or equivalent authorization to practice medicine outside the Republic of Poland. The status of a Manager is verified by providing the name of the Clinic and through internal verification by the Organizer.
8. The Conference will be held onsite and online. Each Participant has the right to choose the method of participating in the Conference.
9. The Conference will be conducted in Polish and in English. The Organizer will provide simultaneous interpretation of lectures and workshops in lectures hall A and B.

10. The Conference is held on June 12th – 14th 2026 in the Radisson Blu Hotel, at Bitwy pod Płowcami str. No.: 54, 81-731 Sopot and will be streamed online via the website www.iade.pl at the following times:

11. The detailed program of the Conference is available at www.iade.pl.
12. Each passive Participant, taking part in the Conference will receive the certificate of participation in the Conference in accordance with the terms as outlined in the General Regulations.

II. Participation, Participant Registration and Resignation

1. The Contracting Party has the right to withdraw from participation in the Conference by April 15th, 2026, without incurring any financial consequences.
2. In the event of withdrawal by the Contracting Party between April 15th, 2026 and May 15th, 2026, the Contracting Party shall be obliged to pay 50% of the Participation Fee, in accordance with the Contract executed between the Parties and the provisions of the General Regulations.
3. In the event of withdrawal of the Contracting Party after May 15th, 2026, the Contracting Party shall be obliged to pay the entire Participation Fee, in accordance with the Contract executed between the Parties and the provisions of the General Regulations.
4. The withdrawal must be expressed in writing and sent to the Organizer's registered office, under pain of invalidity. The date of receipt of the letter at the Organizer's registered office will determine on the acceptance of the withdrawal.
5. The Organizer will provide an Account for the Participants by June 10th, 2026.
6. The rules for registration and participation of Exhibitors are specified in the Terms and Conditions of participation.

III. Payments

1. The participation in the Conference is subject to payment.
2. The Commissioning Party is obliged to pay the Conference Participation Fee in accordance with the price list included in the Regulations and on the Conference website.
3. The fee for passive participation in the Conference shall be made by bank transfer to the account provided by the Organizer, within 7 days of serving the Commissioning party with the proforma invoice or with a pay card (Visa, Mastercard) through the service of an external provider of electronic payment services (Płatności24).

IV. Participation fees

1. The fee for passive stationary participation in the Conference is:

The fixed price for resident doctors below 35 years of age is 1,200.00 PLN (VAT inclusive).

2. The fee for passive online participation in the Conference, available solely for the passive participants is:

The fixed price for resident doctors below 35 years of age is 500.00 PLN (VAT inclusive) for three days of participation.

3. The Organizer offers a special passive participation package for Managers at 1,250.00 PLN (VAT inclusive) comprising the access to the exhibition area on June 12th-14th, 2026 plus the access to selected lectures, specified in the Conference Program.
4. One June 13th, 2026 a banquet dinner with a concert is planned for the Conference Participants at the cost of 600 PLN (VAT inclusive) per person.
5. The fee for passive stationary participation includes admission to all lectures and workshops throughout the Conference , all-day coffee breaks, lunch, invitation to an evening cocktail party, access to the mobile App, and the certificate of participation issued in electronic form.
6. The fee for passive online participation in the Conference includes the access to lecture broadcasts from two conference rooms, and the certificate of participation issued in electronic form.
7. The participation fee does not include post-conference proceedings which are not covered by the conference package. The Organizer reserves the right to send the post-conference proceedings to the participant, via time-limited electronic access (link), which expires after a specified time period, and the Participants will not be able to claim the access the materials.

V. Terms of providing electronic services to passive participants

1. The online participation in the Conference consists in obtaining access to the digital contents via live broadcast of the Conference on the day of the event provided on the Website.

VI. The terms for participation in the Conference and the terms of liability

1. At the end of the Conference, the Participants verified in accordance with the General Regulations will receive an electronic certificate confirming their participation in the Conference. The certificate will be sent by email to the email address provided at the registration.
2. Registrations for the dinner and concert referred to in point IV(6) and payments will be accepted until the limit of places is reached.
3. Th admission to the dinner and concert is solely possible upon presentation of an invitation.
4. Invitations to the dinner and concert for medical doctors participating in the Conference must not be sponsored by pharmaceutical companies, such as manufacturers, importers, and distributors as defined in the Pharmaceutical Law Act of September 6th, 2001.

VII. Image and recording

1. During the event, the Conference area (exhibition and lecture space) will be covered by video surveillance which does not cover sanitary facilities. The detailed information is provided in point XI of the General Regulations.

VIII. Withdrawal from the Contract

1. The details concerning the right to withdraw from the contract can be found in the General Regulations.
2. A Participant wishing to exercise their right to withdraw from the Contract, must submit a definite statement to the Organizer's registered office or by email to: kontakt@iadea.pl.

IX. Complaints

1. General Regulations contain a section concerning the procedures regarding complaints.
2. All the complaints should be submitted in registered letters with a receipt confirmations to the Organizer's registered office or via email to: kontakt@iadea.pl.

IX. Personal data protection

1. General Regulations and Privacy policy contain information on personal data protection.
2. The Organizer wishes to inform that during the event, the Conference area (exhibition and lecture space) will be covered by video surveillance which does not cover sanitary facilities. The monitoring is carried out to ensure the safety of persons and property, for possible findings, investigations, or defense against claims (Article 6 section 1, point (f) of the GDPR). Only images (without sound) are recorded and stored on a digital medium. Camera recordings are stored for up to 7 days from the end of the Conference or until the end of the proceedings in which the recording may serve as evidence, and then will be deleted. Recordings may only be made available to institutions authorized to access personal data pursuant to applicable law.

X. Final provisions

1. The Organizer reserves the right to amend these Regulations, for reasonable causes and to the extent that is necessary. The contracts concluded before the amendment of the Regulations will be governed by the version of these Regulation in effect on the date of concluding the Contact. The amendment of the Regulations will be effective within not less than 14 days of the publication of the amended version of the Regulations on the Website.
2. The Regulations will be effective from January 1st, 2026 onwards.
